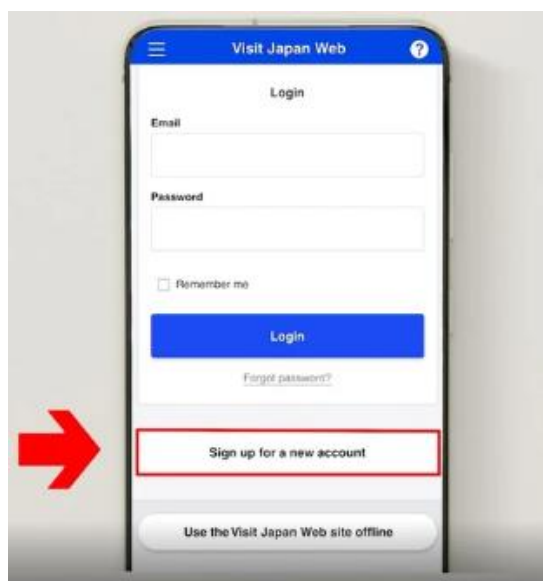


Как пройти регистрацию на веб-сайте Visit Japan?

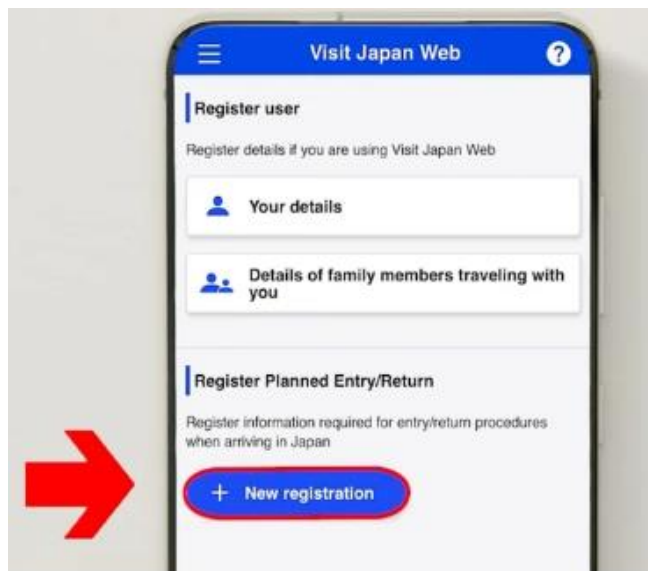

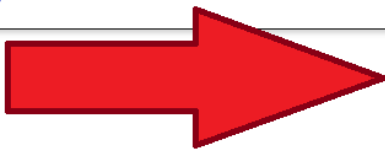
